

## Testing Adherence Collaboration Concrete Questionnaire Guide

**At CRMCA, we would like to continue to expand the Assessment Program. To do so, we must have excited personnel to assist us across the State of Colorado. We invite both concrete producer and engineering laboratory employees to be Assessors. An assessor must be a CRMCA member, have experience and/or knowledge in concrete testing, and hold an ACI Field 1 Technician certification.**

If you registered during the previous version of the Assessment Program, your user login and password will remain the same. If you have not been previously approved to be an assessor in this program or need updated credentials, please contact JT Mesite at [jt@coloradocaa.org](mailto:jt@coloradocaa.org) with the subject line "Assessor request". **You must provide your name, company, email, and a brief summary of your experience (years testing concrete, ACI certification #, supervisor, etc).**

This option can be accessed by non-mobile devices and most mobile devices.





Complete the questionnaire, following each question, depending on responses.

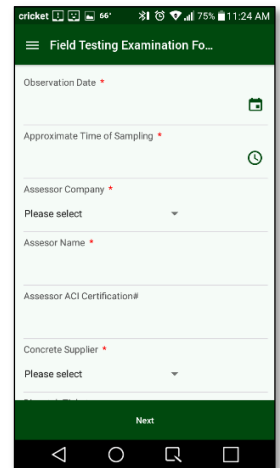
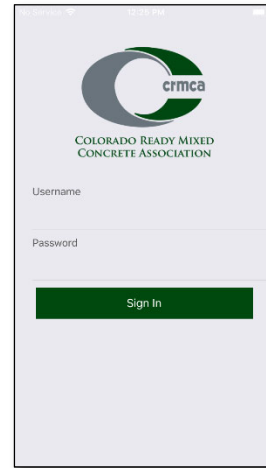
You can upload photos taken by clicking on the image link at the appropriate locations throughout the questionnaire.

If you are not connected to a network when submitting the assessment, the data will be saved and sent the next time the app is loaded while connected to a network.
