





INSTRUCTIONS

This temporary form is for currently certified individuals near or at their certification expiration date in Colorado that are affected by the current COVID-19 pandemic. The COVID-19 pandemic and subsequent emergency actions have caused many disruptions, including rescheduling of ACI Certification education and exam sessions to reduce the risk of spreading the virus. These actions may result in the expiration of ACI Certification of individuals seeking recertification before the rescheduled session takes place. As a result, ACI has been asked to extend certifications so that individuals may remain in compliance with project requirements as they await recertification testing; for a number of reasons, ACI has determined that extending certifications is not the best solution.

Work experience can be performed under multiple employers/companies, resulting in multiple Work Experience Forms sent to various Respondents to meet the requirements. You are responsible for contacting as many Respondents as necessary to submit the required amount of work experience. Respondents must be project superintendents, job foremen, or company owners, who were in direct supervision of the Candidate. Self-employed candidates, please fill out the *Client Affidavit*. ACI believes the Examiner of Record (EOR)/Specifier is the proper individual to review a technician's credentials and determine if a waiver is warranted/appropriate on a temporary basis. This can then be documented in the project files along with an explanation referencing recertification difficulties due to COVID-19 disruptions.

The Candidate completes **Section A** and **Section B**, on multiple forms if necessary, and then sends the entire form to the named Respondent, who completes **Section C** and sends the form directly to Colorado's Local Sponsoring Group, the Colorado Ready Mixed Concrete Association (CRMCA), where the EOR (JT Mesite) will review documentation for approval. All information must be complete and legible.
